WHAT ENVIRONMENTAL RACISM IS



Environmental Racism Defined

A form of systemic racism whereby marginalized Black, Indigenous or communities with people of colour (BIPOC) are disproportionately burdened with health hazards through policies and practices that force them to live in proximity to unsafe environments or climates.

WHO IT AFFECTS

Environmental Racism is a global issue that affects peoples' health, natural environments, and cultures. When toxic waste locations such as sewage works, mines, landfills, power stations, major roads and emitters of airborne particulate matter are placed near BIPOC communities, people suffer.

WHY TEACH IT



Importance of Environmental Racism

Environmental Racism is a topic that should be taught in Ontario Schools as the issue impacts various communities in Canada, and is deeply tied to the marginalization of people. It is our duty as educators to cover these topics as they educate students about issues requiring immediate awareness and attention.

Required Context

In order for educators and students to understand what Environmental Racism is and who it affects, context is required

Historical Context

Environmental Racism can be traced far back in history, but is most notably tied to implications coming from eras of colonialism and racial segregation.

Important Terms

Environmental Racism - A form of systemic racism whereby marginalized communities of colour are disproportionately burdened with health hazards through policies and practices that force them to live in proximity to unsafe environments or climates.

<u>Marginalization</u> - treatment of a person, group, or concept as insignificant

Relationship to the Land - a relationship to land gives some people their identity and a sense of belonging

Perspective - a particular attitude toward or way of regarding something Colonialism - the policy or practice of acquiring full or partial political control over another country, occupying it with settlers, and exploiting it economically

<u>**Grassroots Movement</u></u> - movement that uses the people in a given district, region, or community as the basis for a political or economic movement (collective)**</u>

TOXIC FACILITY SITING IN NOVA SCOTIA

Many regions affected by Environmental Racism have not yet been mapped, leaving opportunities for teachers to practice mapping sites of Environmental Racism with their students

CASE STUDY: GRASSY NARROWS



Grassy Narrows First Nation of Northwestern Ontario has been plagued by levels of mercury in their water, fish, and bloodstreams, with appallingly lacklustre government responses for nearly 50 years. From 1962 to 1970, a now-defunct Dryden paper mill poured 10 tonnes of mercury into the Wabigoon-English River system. Though the situation here has been long-known, Government response in cleaning up the mess, highlights another case of Environmental Racism in Canada toward marginalized Indigenous peoples.
